Updates to NLJRCC Grant (cont'd)

MINOR CHANGES: GRANT ADMINISTRATIVE GUIDE

- Page 4: moved “Scope of Work” to “Application” line.
- Page 4: application timeline.
- Page 5: changed “... grant recipient will receive **disbursements...**” to “... grant recipient will receive **reimbursements...**”.

Updates to NLJRCC Grant (cont'd)

10% REQUIREMENT FOR VICTIM SERVICES

- Grant Administrative Guide Page 2: Removing:
 - “No less than 10 percent of the funds awarded must be distributed to a non-profit organization, faith-based organization, or local agency that provides services to victims of crimes.”
- Grant Application: Page 3: Removing:
 - “How does the applicant intend to select which victim service providers in the community to award funds? Will there be a competitive process?”

Updates to NLJRCC Grant (cont'd)

MINOR CHANGES: GRANT APPLICATION

The goal is to have applicants fill out the application as it has been provided:

- Page 2: changed “Briefly describe the proposed program and its purpose” to “Program/Project’s Scope of Work”.
- All sections, all pages: added page limits.
- Budget spreadsheet provided.

Updates to NLJRCC Grant (cont'd)

APPLICATION TIMELINE

Date 03/15/2024	Grant solicitation released and application period opens
Date 04/12/2024	Preliminary Application due
Date 04/24/2024	Grant Review Committee evaluates applications
Date 05/08/2024	NLJRCC develop recommendations
Date 05/17/2024	NSC makes final award decisions
Date 05/20/2024	Grant period officially begins
Date 12/01/2024	First reporting cutoff date
Date 12/20/2024	First report due to the Interim Finance Committee
Date 06/30/2025	Second reporting cutoff date and all grant funds must be committed
Date 09/19/2025	Grant ends; no grant spending beyond this date
