

# Nevada Local Justice Reinvestment Grant

## 2024 Grant Funding by County

The Nevada Department of Sentencing Policy (NDSP) encouraged entities across the state to submit grant applications for the Nevada Local Justice Reinvestment Grant (NLJR). There was \$3 million total to be granted. The schedule included six rounds of funding running from March 18 through June 21, 2024. **All rounds of funding are closed.**

### County Funding:

One focus of the NLJR grant funds is to fund reentry/recidivism projects in every Nevada county. The table below shows which counties have had entities submit applications for grant funding. Every grant application will be processed and considered.
