

Nevada Local Justice Reinvestment Grant Grant Guide Addendum

The Nevada Department of Sentencing Policy (NDSP) must make the following changes to the Nevada Local Justice Reinvestment Grant's Guide Application Timeline.

Grant Application Response through Friday, April 12, 2024

The response to the original Notice of Funding Solicitation (NoFO) was positive; however, funds are still available.

Grant Application Period Reopens: Tuesday, April 16 through Friday, June 21, 2024

NDSP is reopening the grant application period. Starting Tuesday, April 16 and going through Friday, June 21, 2024, NDSP will accept grant applications on a first come – first served basis.

The NDSP staff will gather, process, Peer Review, and award grant applications on a bi-weekly basis. Also, on a bi-weekly basis, staff will post a list sorted by county and dollar amount, showing the funding that has already been granted. This can be found on the NDSP website: https://sentencing.nv.gov/Grants/Home/. Each time the list is posted, entities in counties that have not yet received funding will be given preference in the next round of funding. This process will end when all funds have been granted or on Friday, June 21, 2024, whichever comes first.

Additional Changes to the Timeline:

The dates and associated activities for **06/30/2025** and **09/19/2025** have been adjusted. The date of **04/30/2025** has been added.
