

# Nevada Local Justice Reinvestment Grant

## Updated Notice of Funding Opportunity

The response to the original Notice of Funding Opportunity (NoFO) for the Nevada Local Justice Reinvestment (NLJR) Grant was positive and grant funds are still available. The grant application period is being re-opened starting April 16, 2024. There will be up to six rounds of funding with the grant application process closing on Friday, June 21, 2024.

**Grant Purpose:** Support counties that are committed to the sustainability of strengthening responses to behavioral health needs of incarcerated persons, focusing jail and prison resources on serious and violent offenders, improving efficiency and effectiveness of community supervision, minimizing barriers to successful reentry, all the while maintaining public safety. Assembly Bill 388 in the 82nd Nevada Legislative Session appropriated a total of \$3 million for this purpose to be granted in the 23-25 biennium. These funds are meant to provide support at the local level, further the goals of justice reinvestment, and deliver data-driven results.

\* When all funds are granted, the remaining rounds will not occur.

**Eligibility:** Eligible applicants are any Nevada non-profit organization, faith-based organization, or local governmental agency (pursuant to matching requirements), who support approved programs within the state, that reduce recidivism, victimization, and maintain public safety. A letter of intent is not required.

**Funding Formula:** The top scoring, qualified applications from each of Nevada's 17 counties will be awarded full or partial funding from the \$3 million appropriation. Grant awards are reimbursable; disbursement arrangements will be evaluated on a case-by-case basis.

**Matching:** Matching is required for all local governmental agency applicants. Thirty percent matching funds will be required. In-kind service and salary matching will be considered to fulfill this requirement.

**Partnerships:** Partnerships are encouraged but not required.

**Formatting:** Applicants can fill in the attached application. If applicants choose to use their own letterhead, applications should be on 8½ by 11 size (letter size) paper, single spaced, using Arial 11-point font with 1-inch margins on all sides.
