### INTRODUCTION

### Statutory Requirements

This report by the Nevada Sentencing Commission (the Commission) is required by NRS 176.01343, which was enacted as part of Assembly Bill 236 (2019) (AB 236). AB 236 went into effect on July 1, 2020. Pursuant to NRS 176.01343, the Commission must prepare and submit to Nevada's Governor, Legislature, and Supreme Court Chief Justice a report that makes recommendations for improvements, changes, and budgetary adjustments with respect to enhancing public safety and controlling correction costs. The statutorily required report may also present additional recommendations for future legislation and policy options to enhance public safety and control correction costs.

Under NRS 176.01343, the Commission is also required to track and assess:

- the outcomes resulting from AB 236 based upon data from the Nevada Department of Corrections (NDOC) (NRS 176.01343(1)(a));
- the outcomes resulting from AB 236 with respect to data collected by the Nevada Division of Parole and Probation (NPP) and reported to the Commission (NRS 176.01343(1)(b));
- trends observed after the enactment of AB 236 from data collected by the Central Repository for Nevada Records of Criminal History and reported to the Commission<sup>1</sup> (NRS 176.01343(1)(d)); and
- outcomes resulting from the enactment of AB 236 with respect to savings and reinvestment (NRS 176.01343(1)(c)).

Finally, NRS 176.01343 requires the Commission to identify gaps in the State's data tracking capabilities related to the criminal justice system and make recommendations for filling any such gaps.

### Summary

In its compliance with the reporting requirements and the other performance and outcome measurement duties of NRS 176.01343, the Commission includes in this report:

### BACKGROUND

In 2019, the Nevada Legislature passed AB 236, a sweeping criminal justice reform bill based on a justice reinvestment initiative intended to address Nevada's growing prison population and the expense of that growth to Nevada's taxpayers. AB 236 was the result of findings and recommendations developed by the Advisory Commission on the Administration of Justice (ACAJ) during the 2017-2018 interim. To develop these recommendations, the ACAJ, with the assistance of the Crime and Justice Institute (CJI), conducted a comprehensive study of Nevada's criminal justice system and identified goals related to justice reinvestment. As enacted, AB 236 is expected to reduce Nevada's incarceration rates through a combination of changes to sentencing and release policies and avoid \$640 million in correctional costs over the ten years following its enactment by:

- Strengthening responses to behavioral health needs of offenders
- Focusing prison resources on serious and violent offenders
- Improving efficiency and effectiveness of community supervision
- Minimizing barriers to successful reentry
- Ensuring sustainability of criminal justice reforms

The data, assessment, information, and recommendations NRS 176.01343 requires and that are provided in this report are the means by which the Commission is to measure the outcomes of AB 236.

Prior to 2019, the Commission was housed in the Legislature as an interim committee to make data-driven policy recommendations concerning sentencing and corrections. Assembly Bill 80 (AB 80) from the 2019 Legislative Session moved the Commission to the Executive Branch by housing it in the newly established Nevada Department of Sentencing Policy (the Department). The Department assists the Commission with carrying out its duties as they existed in the Legislative Branch in addition to the duties required by AB 236.

### DATA FROM NDOC

### Statutory Requirements

NRS 176.01343(1)(a) requires the Commission to track and assess the outcomes of AB 236 based on data from NDOC for three general categories of information or caseload types – prison admissions, parole and release from prison, and prison population.

- For **prison admissions** data, the statute requires:
  - the total number of persons admitted to prison by various demographic and other inmate information measures;
  - the average minimum and maximum sentence term by various demographic and other inmate information measures; and
  - the number of persons who received a clinical assessment identifying a mental health or substance use disorder upon intake.
- For information regarding **parole and release from prison**, the statute requires:
  - the average length of stay in prison for each type of release by various demographic and other inmate information measures;
  - the total number of persons released from prison each year by various demographic and other inmate information measures;
  - the recidivism rate of persons released from prison by type of release; and
  - the total number of persons released from prison each year who return to prison within 36 months by various demographic and other inmate information measures.
- For the **prison population**, the statute requires:
  - the total number of persons held in prison on December 31 of each year by various demographic and other inmate information measures;
  - the total number of persons held in prison on December 31 of each year who have been granted parole by the State Board of Parole Commissioners but remain in custody, and the reasons therefor;
  - the total number of persons held in prison on December 31 of each year who are serving a sentence of life with or without the possibility of parole or who have been sentenced to death; and
  - the total number of persons as of December 31 of each year who have started a treatment program while in prison, have completed a treatment program while in prison and are awaiting a treatment program while in prison, by type of treatment program and type of offense.

### Data Reporting and Collection

NRS 176.01343 does not mandate how the required data is to be collected or reported to the Commission. The Department met with the NDOC on a regular basis to review these statutory requirements and learn how data is collected, stored, and aggregated at NDOC. The Department and NDOC also collaborated on how the data should be reported. The Department learned that the NDOC collects and stores its data using the Nevada Offender Tracking Information System (NOTIS). The Management Information System Section (MIS) at NDOC provides the technical support required to extract data from NOTIS. NDOC staff then reviews the data extracted and may aggregate, disaggregate, and clean the data as needed.

The NDOC informed the Department that there would be challenges in reporting some of the data required. These are discussed in detail in the next section of this report; however, a couple are worth noting here. First, some of the data is being collected but has never been extracted and reported. The NDOC explained that, in advance of reporting its data, it anticipated working with MIS to develop the methods for extracting this data and its staff would determine what additional work would be needed to clean the data for reporting. Second, the NDOC noted that there could be data measures that it had not collected, and that the NDOC staff would begin the process for determining if and how these data measures could be collected.

The NDOC submitted data to the Department on October 1, 2020. After reviewing the data submitted and in consultation with CJI, the Department decided to develop a data template that NDOC would complete and submit to the Department. Based on the measures identified in the statute's data reporting requirements, the Department assisted the Commission in developing this data template, which the Department provided to NDOC. Using this data template, NDOC resubmitted the required data as follows<sup>2</sup>:

### Findings

This being the first collection of data required by NRS 176.01343, the Commission does not yet have historical or comparative data on which it can measure outcomes of AB 236 with respect to data from NDOC. The NDOC data provided in this report will serve two major purposes. First, this data provides a basis on which to build historical and comparative data for future reference. Second, this first collection of data from NDOC identifies issues and areas of opportunity to improve future data collection.

In providing its AB 236 data, NDOC noted that some of the measures that AB 236 requires overlap with the data that NDOC provides for other reporting and that it was able to extract that data to report in the template. To ensure that the variables NDOC extracts for its AB 236 reporting obligations meet the legislative requirements, NDOC stated that it continues to test those variables, and as it identifies how its data tracking may need to change to make future reporting more sustainable and reliable, it will make any necessary adjustments.

NDOC also reported facing some challenges in extracting the data that AB 236 requires. According to NDOC, one challenge was reporting on categories of information it had not previously reported. While NDOC may have been tracking some of those categories of information, if it had not yet reported that data, NDOC had to cleanse and/or aggregate that data for purposes of reporting it in the AB 236 data template.

Another challenge for NDOC was AB 236's requirement that it report on data it has not tracked or collected. For those categories of data, NDOC is unable to provide that statistical data at this point. NDOC has indicated that it will be further evaluating whether such data can be tracked and reported or provided in future cohorts.

Finally, there are some required data measures, such as those related to sexual orientation and gender identity or expression, that NDOC collects and reports as part of the Prison Rape Elimination Act (PREA) and that are protected by privacy regulations. However, NDOC advised that if the Department enters into a data sharing agreement on behalf of the Commission, it would be possible for NDOC to report such measures.

### DATA FROM NPP

### Statutory Requirements

NRS 176.01343(1)(b) requires NPP to collect and report certain data to the Commission to enable the Commission to track and assess outcomes of AB 236. NPP is required to collect and report two general categories of information – the number of persons on probation or parole, and those persons on probation or parole who violate a condition of supervision or commit a new offense.

- For the number of **those on probation or parole**, NRS 176.01343(1)(b) requires:
  - the total number of supervision intakes by various demographic and other supervisee information measures;
  - the average term of probation imposed for persons on probation by type of offense;
  - the average time served by those on probation or parole by type of discharge, felony category and type of offense;
  - the average time credited to a person's term of probation or parole as a result of successful compliance with supervision;
  - the total number of supervision discharges by type of discharge (honorable discharge, dishonorable discharge, and return to prison);
  - the recidivism rate of those discharged from supervision by type of discharge;
  - the number of those identified as having a mental health issue or a substance use disorder; and
  - the total number of those on probation or parole who are located within this State on December 31 of each year.
- For those on probation or parole who violate a condition of supervision or commit a new offense, NRS 176.01343(1)(b) requires:
  - the total number of revocations and the reasons therefor (including a mental health issue or substance use disorder);
  - the average time credited to a person's suspended sentence or the remainder of the person's sentence from time spent on supervision;
  - the total number of those receiving administrative or jail sanctions, by type of offense and felony category; and
  - the median number of administrative sanctions NPP issued to those on supervision, by type of offense and felony category.

### Data Reporting and Collection

NRS 176.01343 does not specify how NPP is to report its data to the Commission. As it did with NDOC, the Department met with NPP on a regular basis to review the statutory requirements and collaborate on how the data should be submitted. NPP also informed the Department how it collects, stores, extracts, and reports data. NPP collects and stores data through the Offender Tracking and Information System (OTIS), and extracts its data through Crystal Reports. After the data is extracted, staff at NPP then cleans and aggregates the data.

NPP indicated that there would be many challenges in reporting the data required by AB 236. These will be discussed in further detail in the next section of this report. Additionally, the next section of the report will provide information regarding the new vendor that NPP has obtained for collecting, extracting, and reporting data.

Just as it did with NDOC, the Department decided, in consultation with CJI, to develop a data template that NPP would complete and submit to the Department. Based on the measures identified in the statute's data reporting requirements, the Department assisted the Commission in developing this data template, which the Department provided to NPP. Using the reports currently available through Crystal Reports, NPP completed the template and submitted the data as follows:

### Findings

Of the data measures AB 236 requires it to report, NPP, through OTIS and Crystal Reports, was able to provide data regarding:

- the total number of persons on probation or parole
- the total number of persons on probation or parole by felony category
- the total number of persons on probation or parole by sex
- the total number of supervision discharges
- the total number of persons on probation or parole located within Nevada on December 31, 2019
- the total number of persons on probation or parole whose probation or parole was revoked for violating a condition of supervision.

As with NDOC, there is not yet historical or comparative data against which the Commission can measure the outcomes of AB 236 with respect to NPP's data. This data provides a basis on which to build historical and comparative data for future reference and identifies issues and areas of opportunity to improve future data collection.

NPP's observations and feedback in reporting its AB 236 data are worth noting. According to NPP, the information and data it primarily tracks are caseload data related to how many individuals are being supervised, who is supervising those individuals, and the offenses for which the individuals are on parole or probation. This means there were data measures required by AB 236 that NPP was not able to report. Either the data measures were not being collected or the data measures were collected but the data had never been reported. If the data has never been reported, NPP must generate a new report in Crystal Reports, and its staff must then clean and aggregate or disaggregate the data by hand. Additionally, the data might be indicated in a field or source that cannot be captured by a report, in which case it would need to be hand counted. Because NPP does not currently have the staff or budget to extract, clean, and aggregate certain data as it is stored, NPP was unable to provide data for all of the measures AB 236 requires for the first collection of data.

However, NPP is preparing to switch to a new data collection, storage, and reporting system through Tyler Technologies, and has stated that it expects to make the transition to that system between September and December 2021. According to NPP, the new data system is intended to be highly configurable, allowing NPP to collect and track all of the data required by AB 236 and to aggregate that data into usable information for purposes of AB 236's reporting requirements.

### DATA FROM CENTRAL REPOSITORY

### Statutory Requirements

NRS 176.01343(1)(d) requires the Commission to track and assess trends observed from data collected and reported to the Commission from the RCCD regarding:

- The uniform crime rates for Nevada and each of Nevada's counties by index crimes and type of crime; and
- The percentage changes in uniform crime rates for Nevada and each of Nevada's counties over time by index of crimes and type of crime.

### Data Reporting and Collection

The Department met with RCCD on a regular basis to review the statutory requirements and collaborate on how data would be submitted to the Department. RCCD did not anticipate any challenges in reporting the data and submitted its data in a report on October 1, 2020.

After the data was received, the Department decided, in consultation with CJI, to develop a data template based on the statutory requirements to facilitate the collection of data. Using the data template created and provided by the Department and the Commission, RCCD resubmitted the data required by AB 236. RCCD reported data from 2019 that is based upon data it collects from various and numerous Nevada state and county agencies and stores in a centralized repository database.<sup>45</sup> In reporting its data, RCCD explained:

- It included data from 2018 and 2019, which is data on which RCCD calculated the percentage change in the crime rate;
- Any increase from 0 is calculated as a 100% increase; and
- If an agency did not submit 12 months' worth of information, there will not be any data for either 2018 or 2019.

## Findings

As with the data collected from other agencies, there is no historical or comparative data at this point against which the Commission can measure the outcomes of AB 236 with respect to the data reported by RCCD. This data provides a basis on which to build historical and comparative data for future reference. However, the historical and comparative use of this data will be limited. RCCD is in the process of transitioning Nevada to the National Incident-Based Reporting System (NIBRS) as required by the Federal Bureau of Investigation (FBI). Because the source of the data will be different, the Commission may not be able to establish a baseline until the next submission of this report. The Commission will need to determine how to use the data collected for this report with data collected for future reports.

For the purposes of this report, RCCD explained that because most of the data that AB 236 requires it to report overlaps with what RCCD already reports to the Federal Bureau of Investigation and because it was otherwise able to aggregate available data to comply with the statutory requirements, it did not encounter any significant challenges or obstacles in reporting the data required of it by AB 236. However, because the data RCCD reports is based upon data that state, county, and city law enforcement agencies report to it, RCCD's data reports are as complete and accurate as the data it receives. Notably, there are agencies that, despite being required to do so, did not report data to RCCD for the year 2019.<sup>47</sup>

Going forward, and with the exception of any city, county, and/or state agencies that do not report their data, RCCD does not anticipate any challenges in submitting data using NIBRS. However, RCCD, the Department and the Commission will communicate and collaborate to ensure compliance with the statutory requirements and address any challenges that may arise or how calculations will need to be adjusted.

# **CRIMINAL JUSTICE DATA: GAPS AND RECOMMENDATIONS**

### Statutory Requirements

NRS 176.01343 requires the Commission to identify gaps and make recommendations in Nevada's ability to share criminal justice data. Additionally, NRS 176.0134 requires the Commission to facilitate the development and maintenance of a statewide sentencing database in collaboration with state and local agencies, using existing databases or resources where appropriate.

### Gaps

As discussed above and in footnote 47, the Commission acknowledges the gaps in data with respect to data that was not reported to RCCD by certain agencies. The Commission will evaluate these gaps and determine what, if any, recommendations to make to address these gaps. Otherwise, because this is the first report of its kind, it is premature to identify gaps and make

recommendations as required by NRS 176.01343. For future reports, and in its effort to fulfill statutory duties and appropriately identify gaps in the State's ability to share criminal justice data, the Commission may identify and assess the following among state and local agencies:

- Databases used by criminal justice agencies
- Collection of criminal justice data
- Sharing of criminal justice data with agencies and the public
- Aggregation of criminal justice data
- Disaggregation of criminal justice data
- Use of existing databases
- Use of resources
- Ability to track an individual through the criminal justice system

Finally, the Commission acknowledges that currently, there is no statewide or common database for collecting or sharing criminal justice data in Nevada. As the Commission continues to track, collect, and assess the collection of data from Nevada's various agencies, it will identify specific areas where data cannot be shared and what gaps in data or data sharing may exist.

### Recommendations

Because AB 236's July 1, 2020, effective date is so recent, sufficient time has not yet passed for the Commission to be able to make recommendations for filling any gaps identified in data tracking capabilities related to the criminal justice system. The AB 236 data reported by NDOC, NPP, and RCCD provides a baseline for future tracking and assessment of data collection capabilities and outcomes of AB 236.<sup>48</sup> Notwithstanding that there is not currently historical and comparative data needed to make data-driven recommendations, the Commission recommends the continued collaboration between the Department, NDOC, NPP, RCCD, and other criminal justice agencies in the collection of data required by AB 236.

The Commission also acknowledges that, in their respective efforts to comply with their AB 236 data reporting, the agencies had questions for the Commission as to the scope and specificity of certain data categories and/or measures. It is appropriate for the Commission to provide clarity and specificity on those certain data measures to help guide the agencies in reporting them in a

manner that will assist the Commission in fulling its statutory duties.<sup>49</sup> Any guidance, requests, or recommendations with respect to reporting this data will be identified in future reports.

## SAVINGS AND REINVESTMENT

## Statutory Requirements

NRS 176.01343(1)(c) requires the Commission to track and assess the outcomes resulting from the enactment of AB 236 with respect to savings and reinvestment, including:

- the total amount of annual savings resulting from the enactment of any legislation relating to the criminal justice system;
- the total annual costs avoided by the State of Nevada because of the enactment of AB 236 as calculated pursuant to NRS 176.01347; and
- the entities that received reinvestment funds, the total amount directed to each such entity and a description of how the funds were used.

## Projected Amount of Costs Avoided

The Commission submitted its Projected Amount of Costs Avoided Report in August 2020.<sup>50</sup> The projected amounts for the costs avoided were as follows:

- 2022
  - Baseline: \$28,914,832.80
  - Worst Case: \$21,270,681.60
- 2023
  - o Baseline: \$30,576,604.80
  - Worst Case: \$26,442,946.95

These amounts were calculated using the February 2020 JFA Prison Population Projections, which identified two different assumptions to be used for the forecasts – "Baseline" and "Worst Case." The Commission's calculations were based on those assumptions and scenarios and reported those amounts using the terms JFA assigned to its assumptions.

## Statement of Costs Avoided

The Commission submitted its Statement of Costs Avoided in December 2020.<sup>51</sup> Because AB 236 only recently went into effect, there were no costs avoided to calculate for Fiscal Year 2020. Instead, the Commission identified the formula that will be used to calculate the costs avoided in future statements and reports.

## RECOMMENDATIONS

The Commission is required to include in this report the following with respect to enhancing public safety and controlling correction cost recommendations for:

- Improvements
- Changes
- Budgetary adjustments

This report may also include additional recommendations for future legislation and policy options to enhance public safety and control correction costs. However, because AB 236 only went into effect July 1, 2020, it is premature for the Commission to provide any recommendations with respect to enhancing public safety and controlling correction costs. The Commission looks forward to tracking and assessing the outcomes resulting from the enactment of AB 236 and will report its findings and recommendations using the framework provided in this report.
