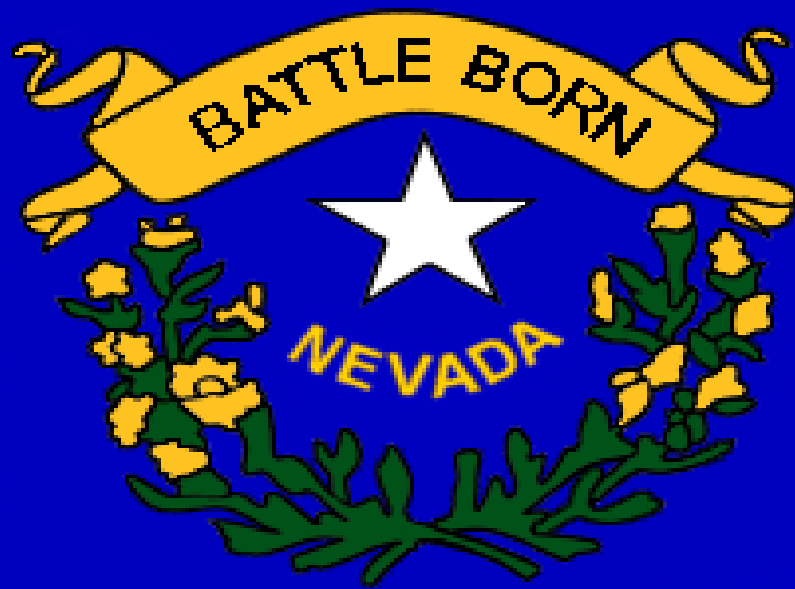


### Mission:

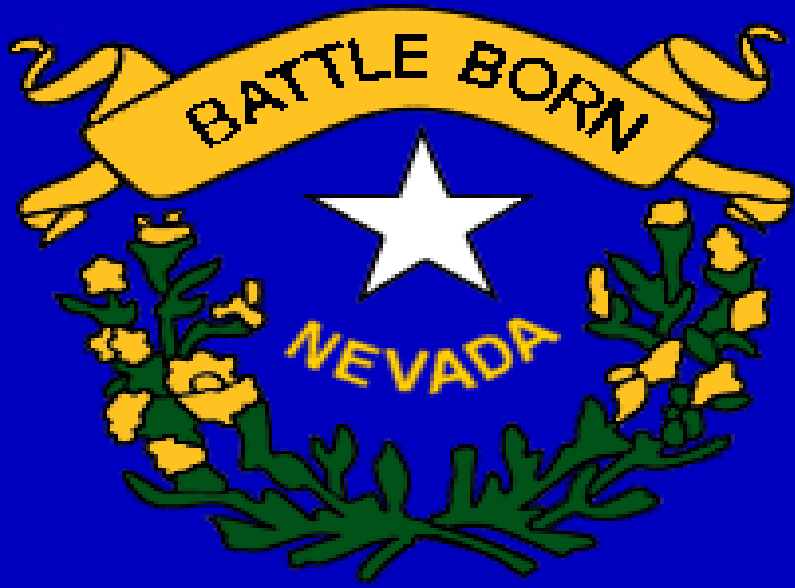

## NDOC's Re-Entry Philosophy:

### Re-Entry begins at Intake

These Programming/Re-Entry driven processes take place during Intake at the NDOC

1. Nevada Risk Assessment System (NRAS) administered and results electronically recorded in the Nevada Offender Tracking Information System (NOTIS)  
\*programming assigned is determined based on Risk/Need factors/scoring
2. Mental Health Review/Classification Completed
3. Birth Certificate and Social Security applications are provided, completed and submitted
4. Official identification received in property during Intake is inventoried, logged and secured into the Institutional File (I-File)
5. ***Comprehensive Case Planning and wait list populated in NOTIS – in development***

## NDOC's Re-Entry Legislation: 81<sup>st</sup> Legislative Session

### Assembly Bill 16

AN ACT relating to vital statistics; prohibiting the charging of fees for the issuance of copies of certificates and records of birth to persons who are imprisoned; and providing other matters properly relating thereto.

Existing law prohibits the charging of fees for the issuance of copies of certificates and records of birth to homeless persons and persons released from prison within the immediately preceding 90 days. (NRS 440.175, 440.700) This bill prohibits the charging of such fees to persons who are imprisoned.

## NDOC's Re-Entry Legislation:

### 81<sup>st</sup> Legislative Session

#### Senate Bill 32

AN ACT relating to offenders; revising provisions governing certain programs of treatment for offenders established by the Director of the Department of Corrections; and providing other matters properly relating thereto.

Existing law requires the Director of the Department of Corrections, in conjunction with the Division of Public and Behavioral Health of the Department of Health and Human Services and with the approval of the Board of State Prison Commissioners, to establish therapeutic communities to provide treatment to certain offenders with substance abuse disorders. (NRS 209.4236) Section 8 of this bill eliminates the requirement the Director establish such therapeutic communities and instead requires the Director to establish programs of treatment for offenders with substance abuse or co-occurring disorders.

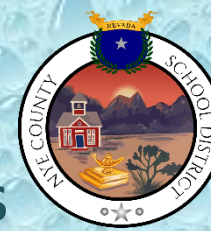
