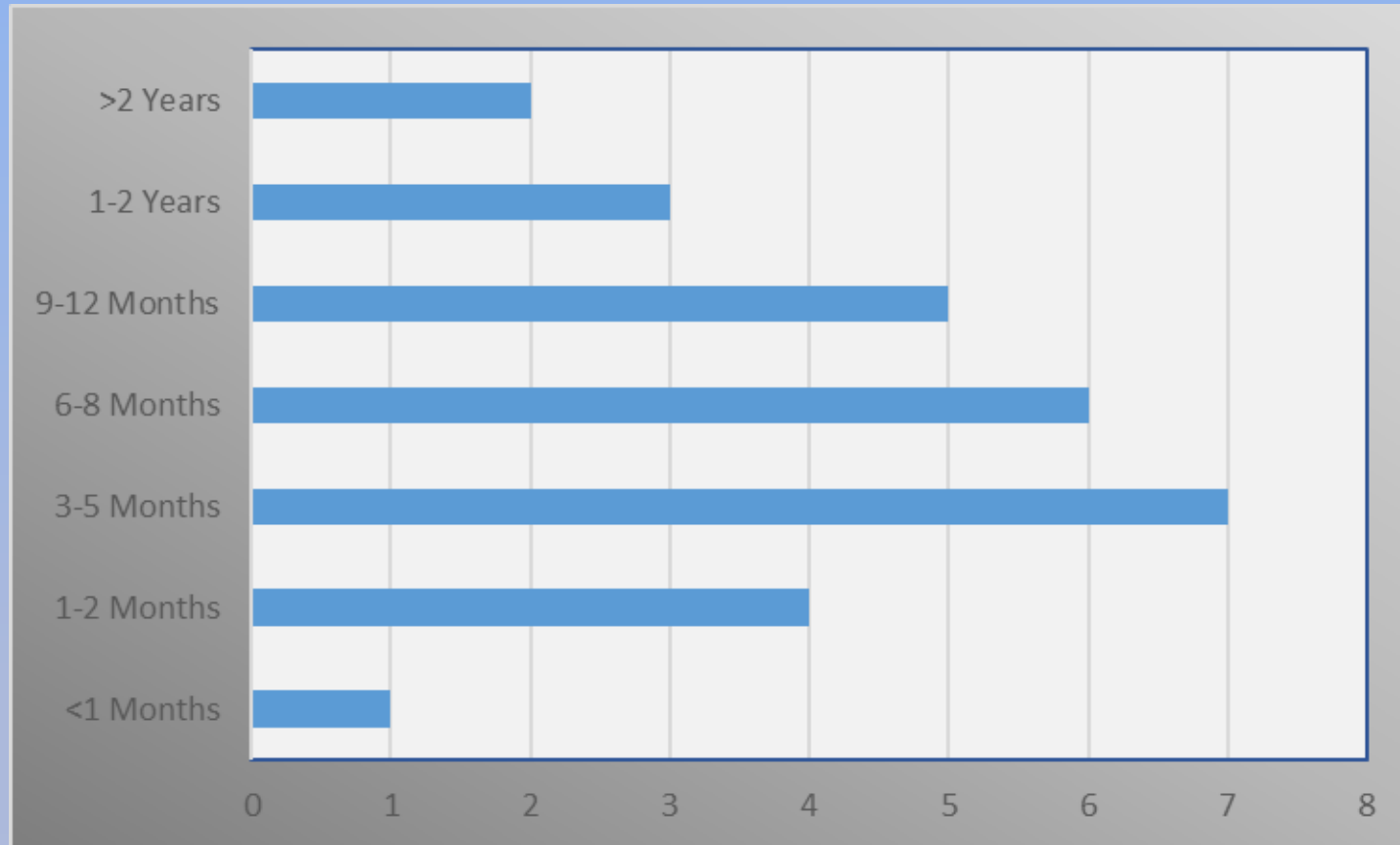
Revocation Hearing Results



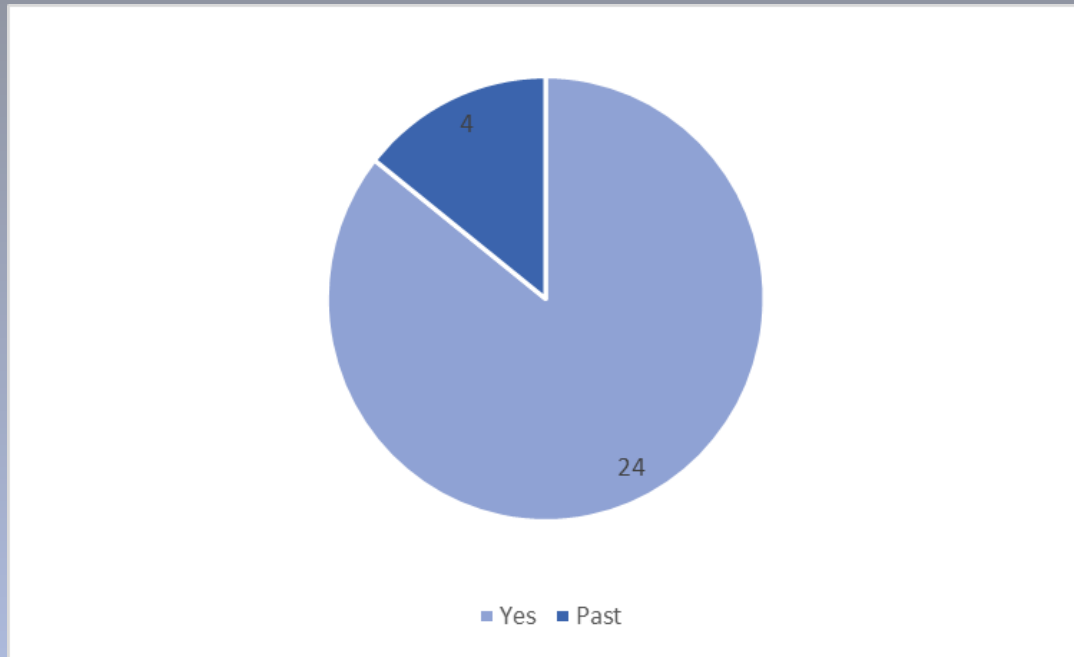


TIME ON PAROLE

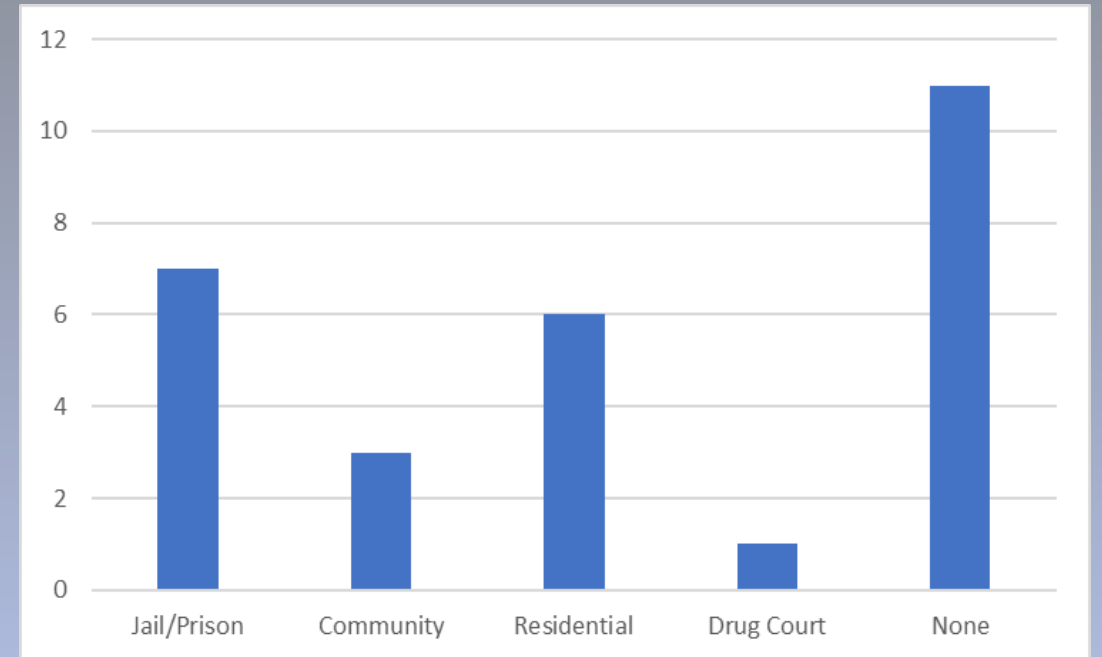
How long were you on Parole?



Do you have substance use issues?

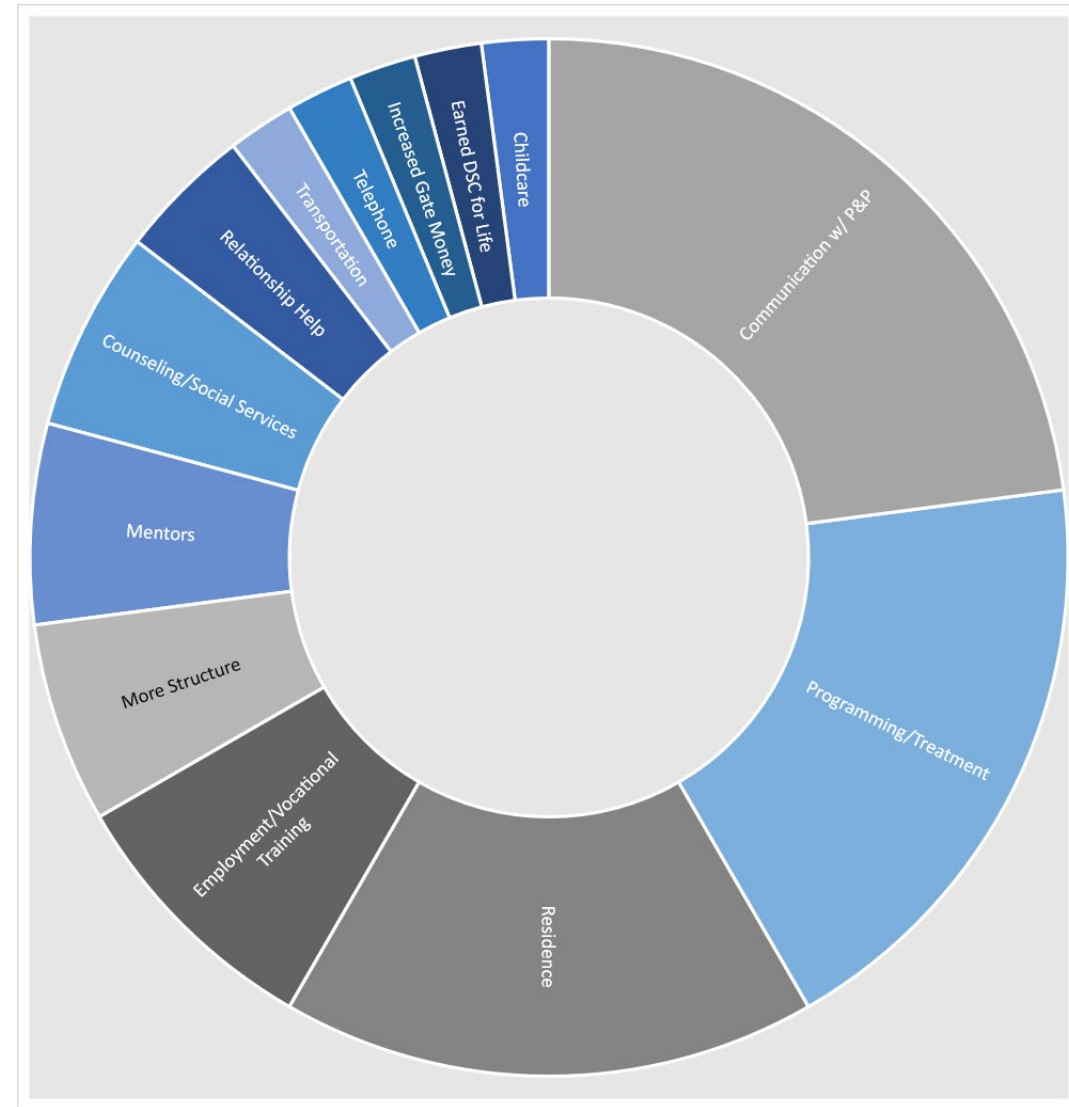
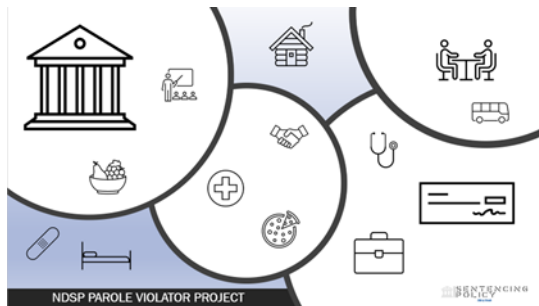
