AB 236 (2019) Amended Certain Offenses

Burglary

- Carved out different types of burglaries (motor vehicle, structure, business, residence)
- Specified penalties for each type of burglary

Theft


- Amended thresholds
- Specified felony category for each threshold

Drug

- · Amended thresholds
- Specified felony category for each threshold


Habitual offenses

Modified the thresholds for charging a "lesser habitual" or "greater habitual"





Admissions by Offense Group Percentage of Total Admissions


- Admissions are down
- •Felony category B, C, D, and E admissions all decreased significantly
- Property admissions decreased by almost 50% (comparing 2017 and 2021)
- •Drug admissions decreased by over 50% (comparing 2017 and 2021)
- •Decrease in admissions among drug and property offense groups consistent with changes from AB 236 (2019)





Releases by Offense Group - Percentage of Total Releases


Releases - Findings

- Felony category B releases higher than category C and D releases combined
- •Decrease in felony category C and D releases most likely because of the decrease in admissions among these felony categories
- •Decrease in admissions and increase in releases contributes to lower prison population




2017 Admissions and Releases Comparison by Offense Group




2021 Admissions and Releases Comparison by Offense Group




2022 Admissions and Releases Comparison by Offense Group




Admissions and Releases Comparison: Violence Offense Group




Admissions and Releases Comparison: Drug Offense Group




Admissions and Releases Comparison: DUI Offense Group






Admissions and Releases Comparison - Findings


- Increase in releases across most offense groups
- •Most recent trends show that admissions and releases are almost even with slightly more releases




Admissions by Category B and C Drug Offense Group





Admissions by Habitual Offenses




Releases by Habitual Offenses



Summary of Findings

- Prison resources focused on serious and violent offenders
 - Composition of prison has changed in all aspects including admissions and releases
- Prison population down because releases outpaced admissions
- •AB 236 (2019) changes to certain offenses affected admissions
- Admissions and releases almost even with slightly more releases
- Prison population has remained relatively even for almost a year
