Communications Bureau

- Dispatch centers in Carson City and Las Vegas servicing our Departmental sworn activities as well as cooperation with federal and local agencies
- Under the direction of the Communications Bureau Chief, both Centers have on-site Managers overseeing day to day operations
- Warrants Unit 24x7x365 coverage for the Attorney General's Office, the Brand Inspector (Department of Agriculture), DPS Capitol Police, Contractor's Board (Reno and Henderson), Department of Corrections, DMV Compliance Enforcement Division, U.S. Housing and Urban Development, DPS Fire Marshal, DPS Investigation Division, DPS Parole & Probation Division, Nevada State Parks Division, Nevada Department of Wildlife, State Welfare Division, State Youth Parole (Las Vegas and Reno), and Elko County Juvenile Probation.

Records Bureau Est. 1985 – 15 Programs

- Nevada Criminal Justice Information System (NCJIS): the computerized information system created to serve all federal, state, and local law enforcement and criminal justice agencies in Nevada and in the nation that require criminal justice information
- Conduit through which Nevada criminal justice agencies access information systems of Nevada criminal justice agencies, the Federal Bureau of Investigation, other states, and international criminal justice agencies (e.g., Interpol, RCMP)

 - Repository for Information Concerning Orders for Protection (NRS 179A.350)
 - Elder Abuse Reporting Repository (NRS 179A.450)
 - Hate Crimes (NRS 179.175)
 - Use-of-Force (SB212 2021 Legislative Session)
- State Sex Offender Registry (NRS 179B, 179D)
- Point of Contact Firearms Program for firearms transfers (18 USC 922 (g, n), NRS 202.2547)

Records Bureau Cont.

- Repository for Information Concerning Protection Orders (NRS 179A.350)
- Business Process Management Office
- Centralized storage facility for f/p-based Nevada Records of Arrests and Prosecution (RAP Sheets) and other biometric identifiers
- Fingerprint-based background checks for employment, licensing, permits, individuals providing services to vulnerable populations (various State and Federal statutes), CCW permits, personal IDs, etc.
- Nevada Offense Codes Program
- FBI CJIS Systems Agency for State of Nevada (28 CFR Part 20)
- NCJIS Compliance Unit (Criminal Training, Criminal Auditing, and Civil Auditing) (28 CFR Part 20)
