Dear Members of the Sentencing Commission:

I am writing concerning the recent job posting for the Executive Director of the Department of Sentencing Policy position. I believe my over 25 years of experience in law enforcement and government work, most recently with the court system, has prepared me for this position. During my years as a law enforcement officer, I was a Field Training Officer (FTO) for many years. In this position, I trained new officers right out of the academy as well as lateral officers when they began their careers with the South Lake Tahoe Police Department. I also worked intermittently as an Officer in Charge (OIC) in which I would assume the role of a sergeant and shift commander, which allowed me to put in practice my leadership skills.

To Whom It May Concern:

I am the Justice of the Peace for Canal Township and the supervising judge of Lyon County's Pre-trial Services Department and it is my pleasure to write this letter of recommendation for Donald Poole.

Donald began his employment with Lyon County as a Pre-trial Service Officer in January of 2021 and promoted to the department supervisor in March of 2022. He accepted the position knowing that he would be the only Pre-trial Services Officer in Lyon County and would be expected to interview in-custody defendants, prepare Nevada Pre-trial Risk Assessments, progress and violations reports for four courts and five judges and travel between four courts located within a geographical area of 2001 square miles.

He immediately recognized the need to improve processes and relationships with stakeholders that would ensure the fair and equitable treatment of defendants, improve supervision success and connect offenders with community services. He quickly developed and repaired relationships with stakeholders and obtained their commitments to improve pre-trial services throughout Lyon County. This included bridging the gap between Lyon County Human Services Adult Services Forensic Assessment Services Triage Team (FASTT) and the Mobile Outreach Safety Team (MOST) and Lyon County Courts. Pre-trial Services Officers are now able to obtain the services needed to assist community member experiencing crisis including, but not limited to mental health, emotional, and substance abuse and community re-entry programs.

He played an integral role in developing and implementing the policies, procedures, and process needed to to ensure the success of the pre-trial release program. His efforts have resulted in an average success rate of 80%. The department is now able to collect the data needed to analyse and improve the processes needed to reduce the costs associated with unnecessary detention of individuals, improve supervision success rates and connect defendants with community resources.

Donald is committed to improving our communities' safety, reducing the risk of flight through proper supervision and connecting offenders with services. He is also committed to balancing individuals' rights for due process and maintaining the integrity of the judicial process and protecting victims, witnesses and the community from threat, danger or interference.

Donald's education, work history and personal experiences provide the skills to serve as a strong resource in assisting the Nevada Sentencing Commission in making data-driven sentencing and corrections policy recommendations to the Legislature.
