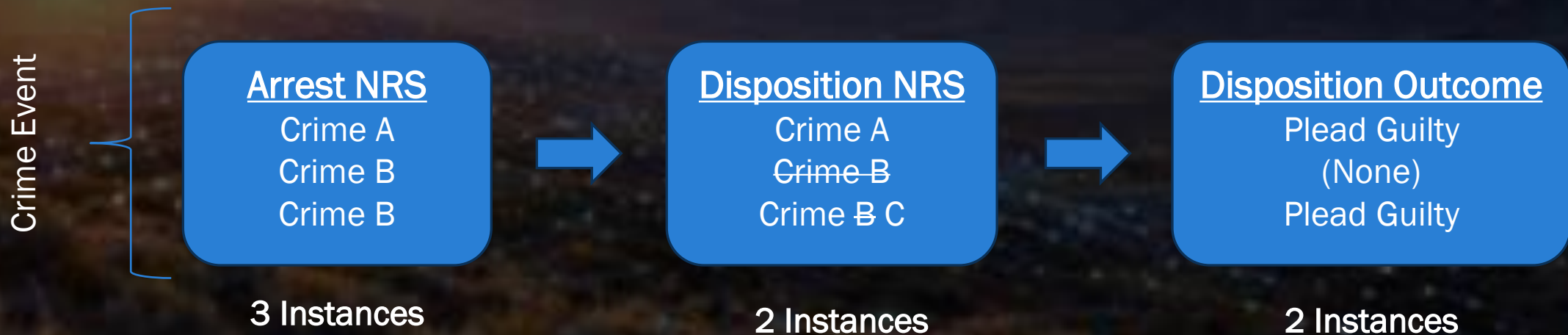
# Dataset Introduction

---

- **Data Source:** Nevada Department of Public Safety's Records, Communication, and Compliance Division (DPS, RCCD)
- January 1, 2006, through December 31, 2025
- Arrest Offense and Disposition Offense
  - Nevada Offense Code (NOC)
  - Nevada Revised Statute (NRS)
  - Offense Description
- Data reflects number of "Instances"

# What is an “Instance”

- For each crime event, there is one individual associated
- For each crime event, there can be one or more instances associated
- There can be changes to the initial arrest information after disposition



# Data Challenges: Amount of Data

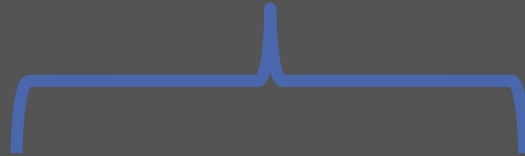

- We are working with 20 years of instances for all felony arrests in the state of Nevada
- We received over 1.2 million instances
- Brand new data that needed time to be collected and processed

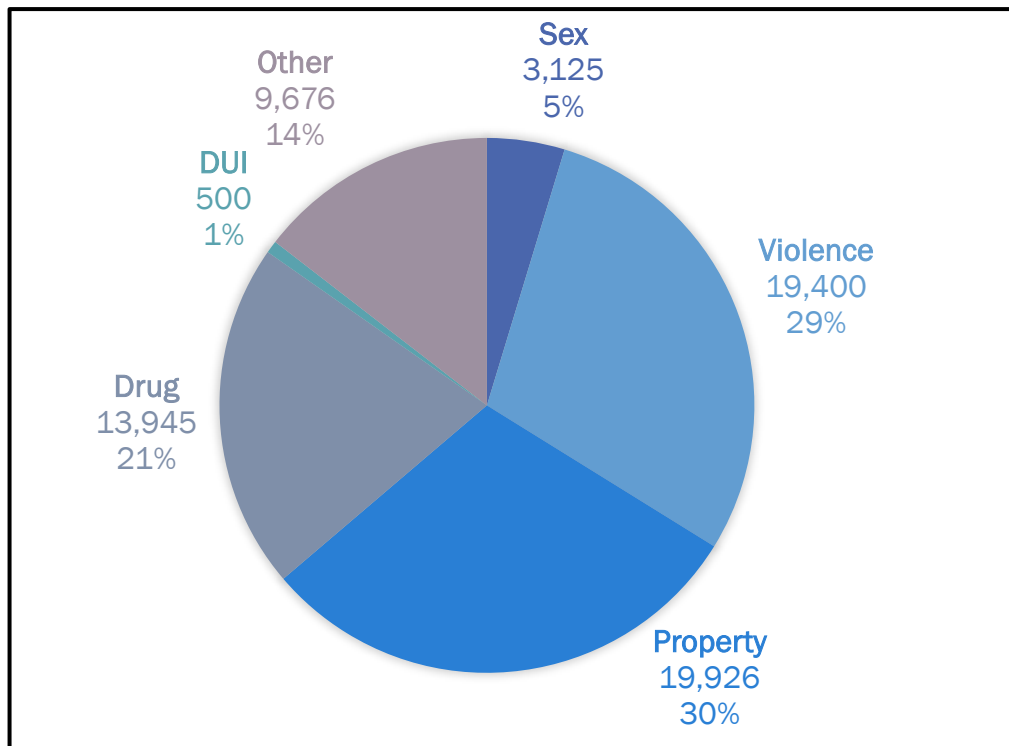


# 2006 – 2025 Instances By Offense Groups

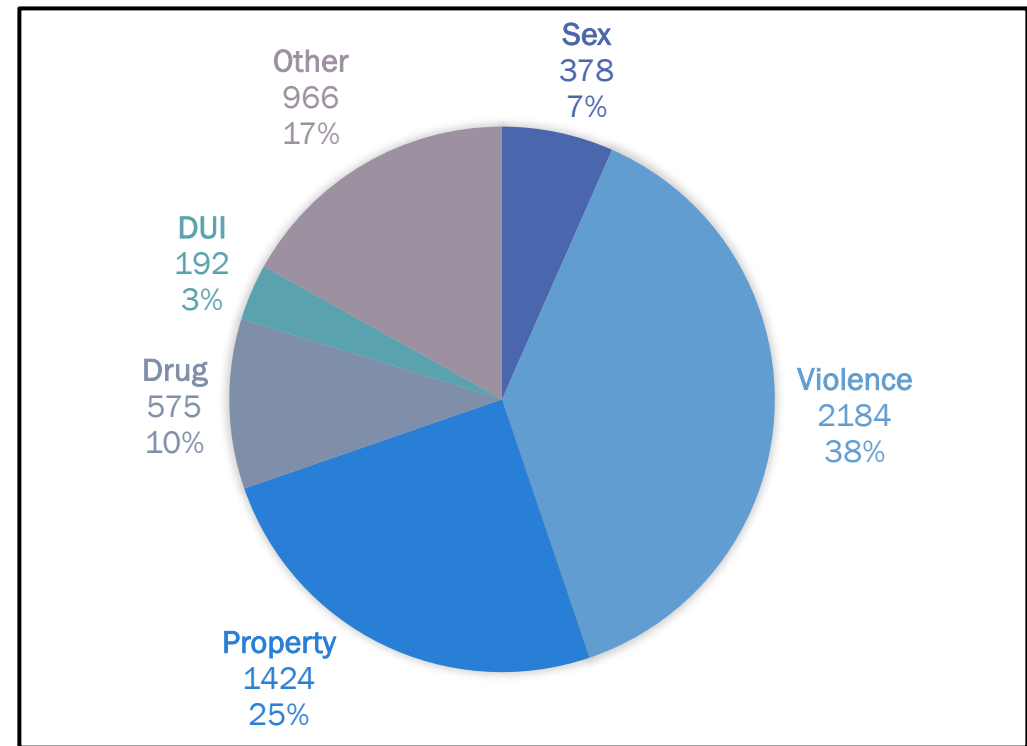


# 2025 Offense Group Comparison

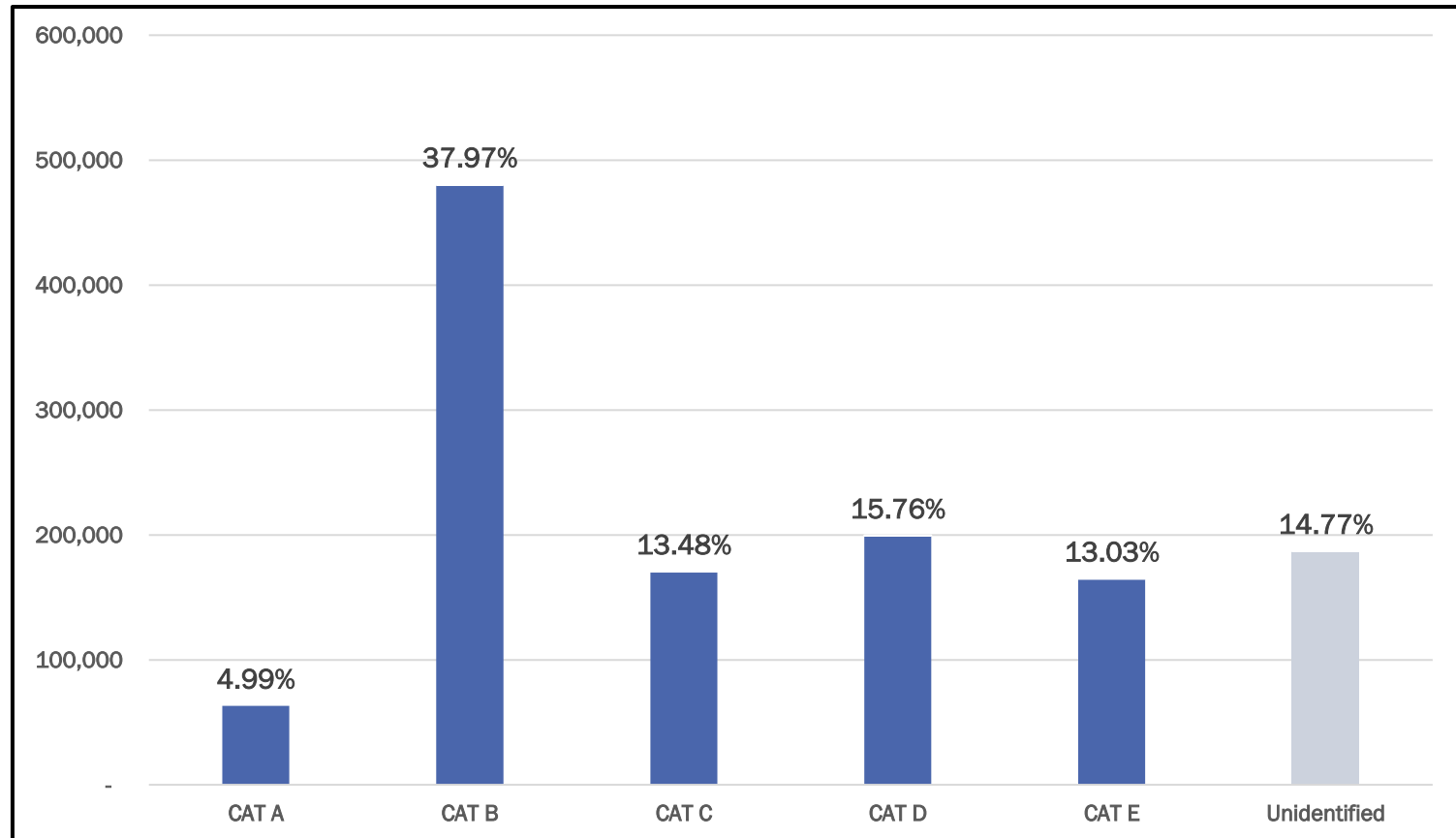

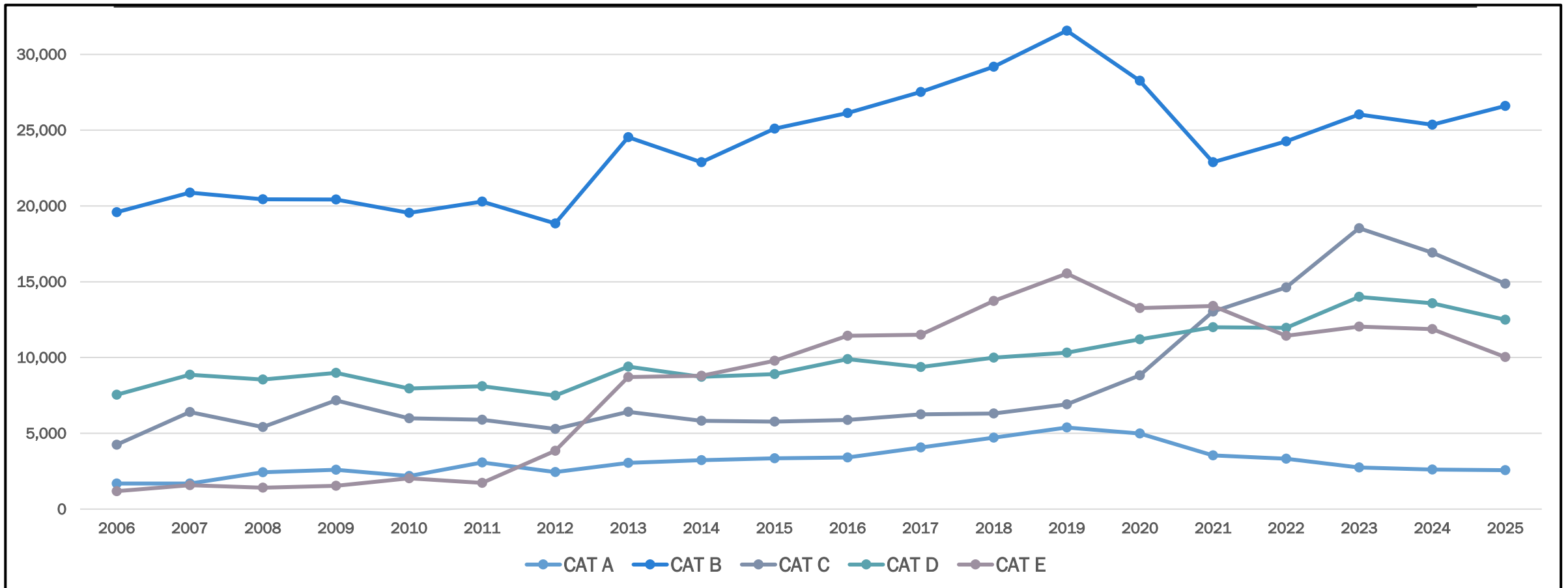

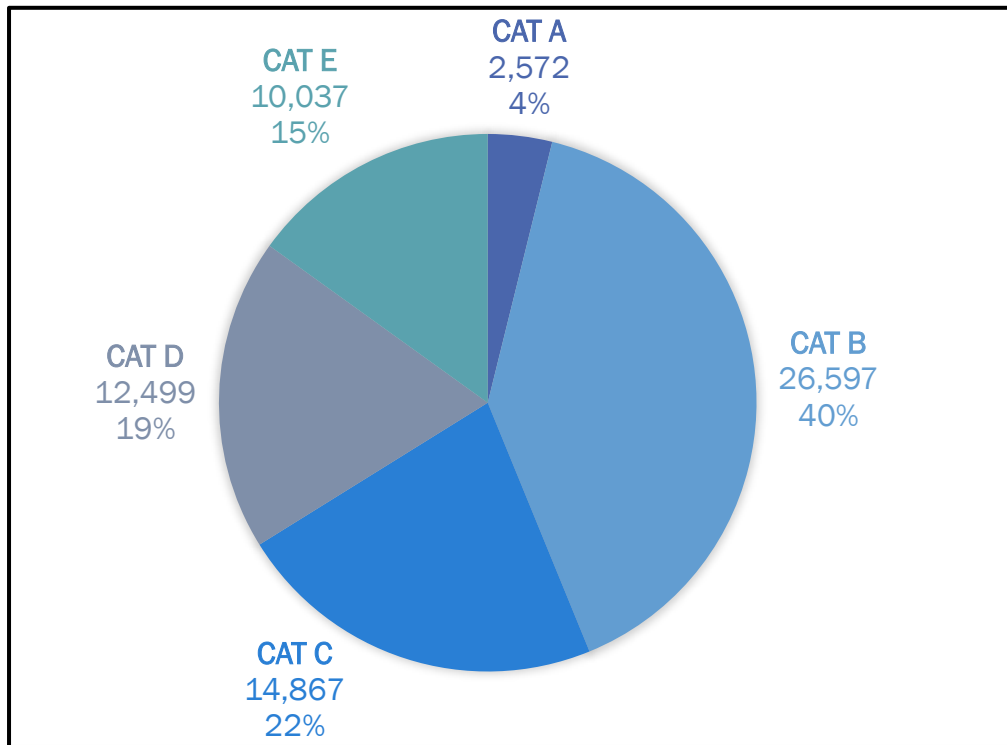


# 2006 – 2025 Instances By Felony Category

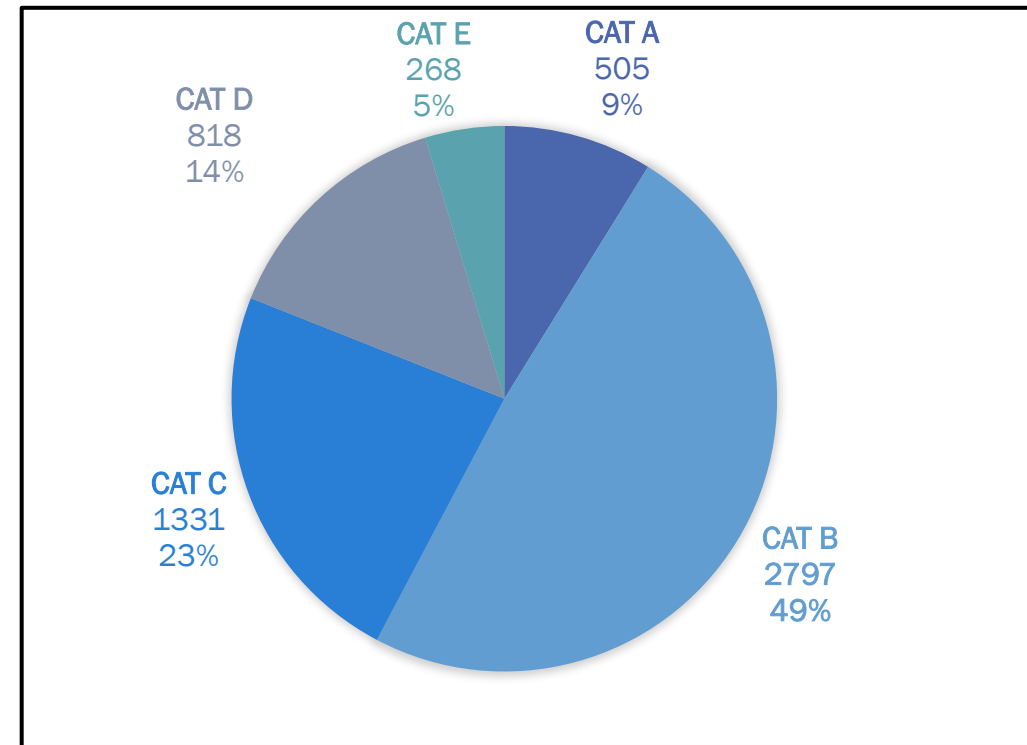


# 2025 Felony Category Comparison

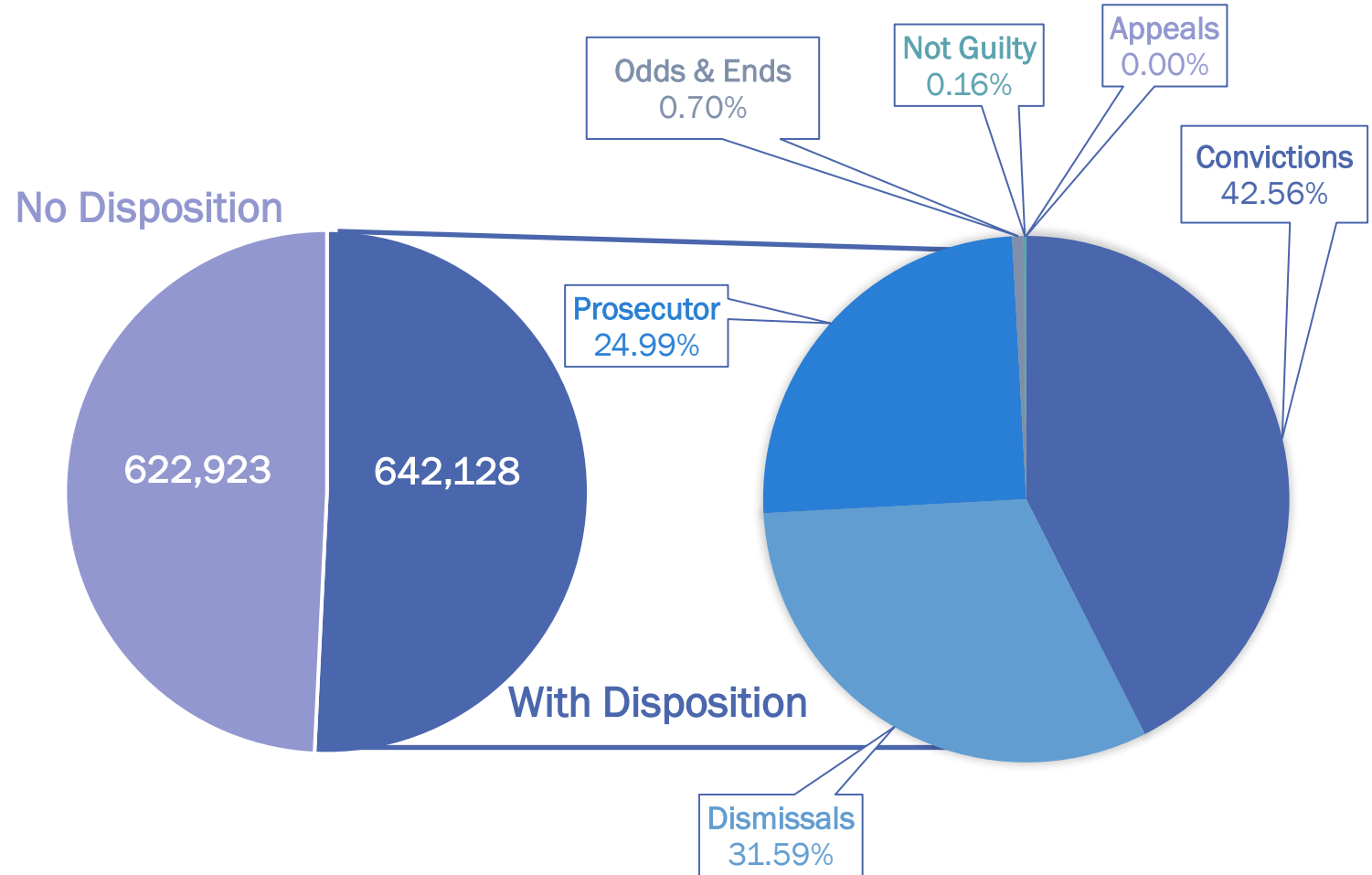

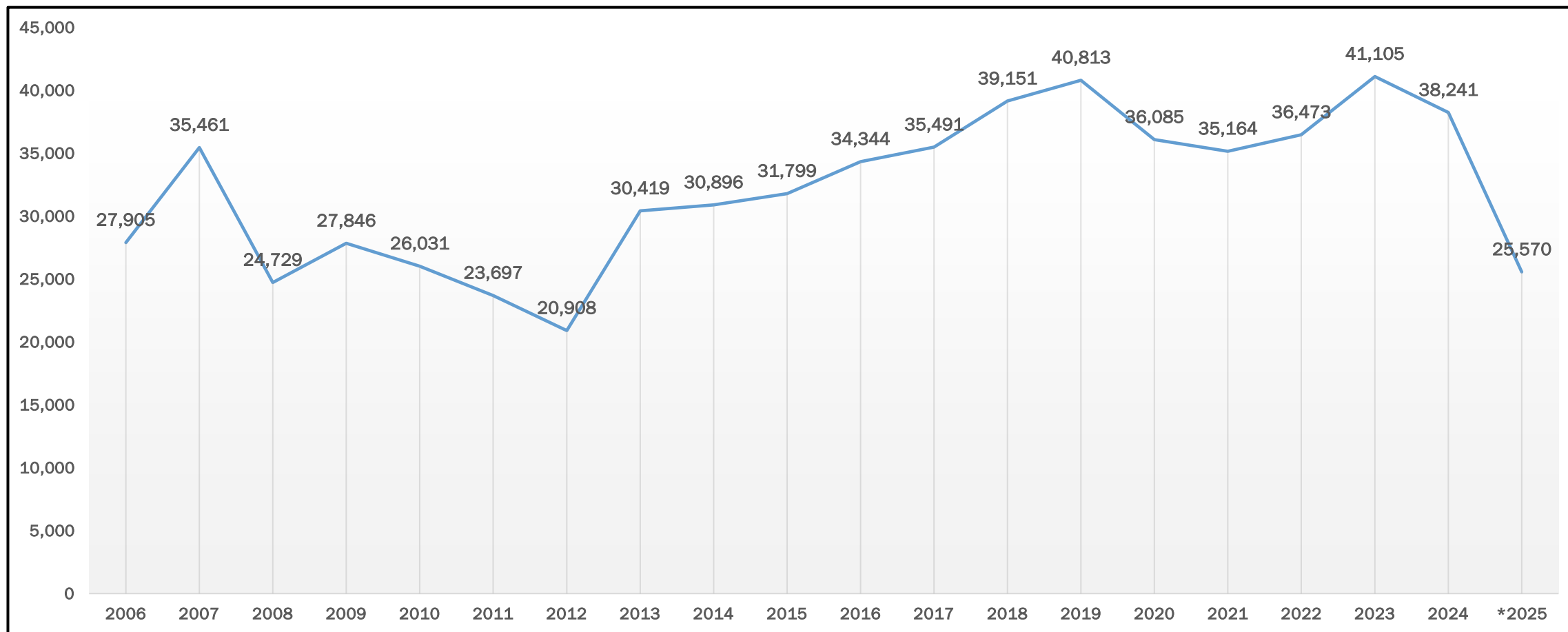

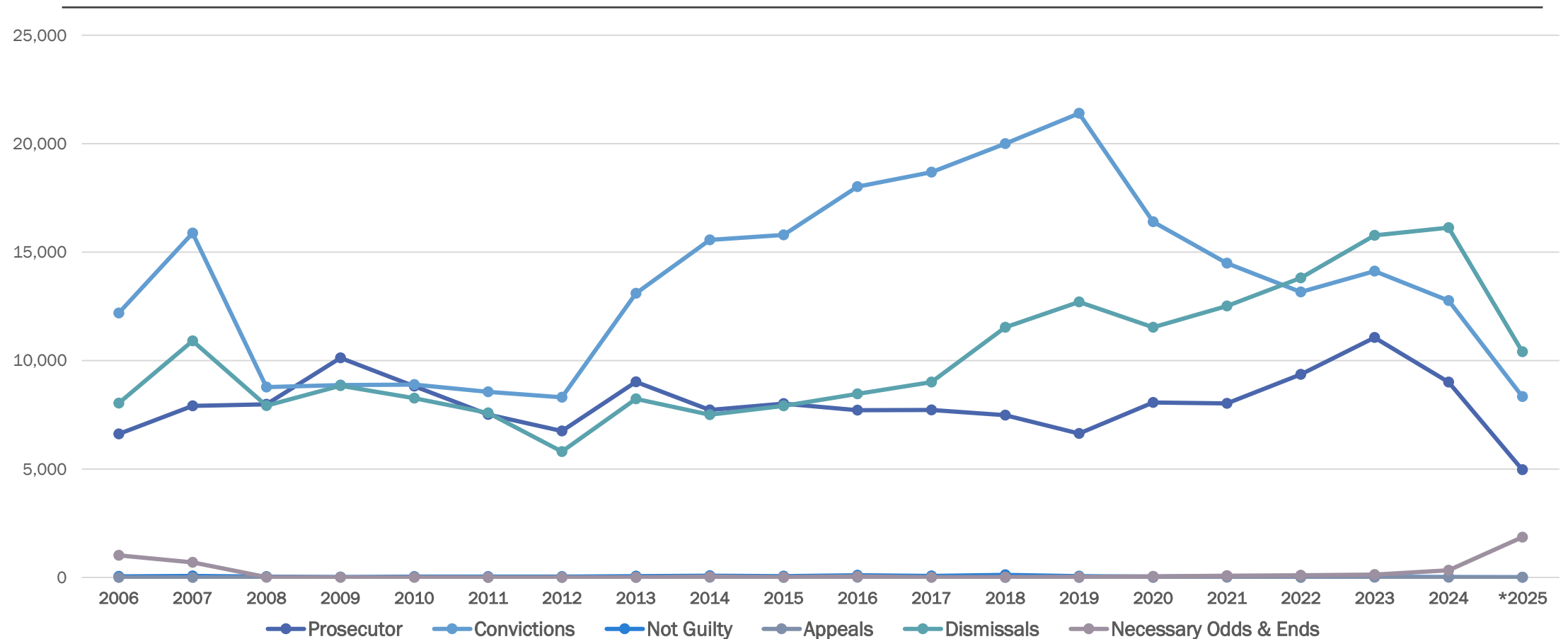
# Instances with Dispositions 2006 - 2025
