Nevada's Current Misdemeanor Classification

- Gross Misdemeanor: 364 days in jail and \$2,000 fine (NRS 193.140).
- Misdemeanor: 6 months in jail, \$1,000 fine, and all or part of punishment maybe converted to community service per subsection 2 (NRS 193.150).
- Some misdemeanors have specific sentencing requirements that vary from the default penalties in NRS 193.150, e.g., violation of NRS 394.700 or NRS 396.990 – Use of False or Misleading Degree requires a \$5,000 fine but is classified as a misdemeanor.
- If a criminal offense exists within NRS and no penalty is prescribed, it is a misdemeanor (NRS 193.151 and NRS 193.160).
- Fine for "public offense" proportionate to value of property affected or lost per <u>NRS 193.155</u> which includes a sub-misdemeanor classification in subsection 4.
- Per <u>NRS 176.059</u>, <u>176.0611</u>, <u>176.0613</u>, and <u>176.0623</u> misdemeanor convictions are subject to administrative assessments in addition to any other penalty. Gross misdemeanors are also subject to a different administrative assessment, see <u>NRS 176.062</u>.
- Civil Infractions supplanted misdemeanors for many traffic offenses per AB116 of the 2021 Session, see <u>NRS 484A.703 to NRS 484A.705</u>. Some traffic offenses remain criminal (see attached list).
- Several misdemeanors are subject to enhancement, meaning either that subsequent violations of the same statute result in increased penalties within a period of time or are subject to additional penalties for the circumstances surrounding the offense (see attached list).
