<b>268.030</b>	Failure to publish quarterly financial statements ((city or county clerk)	Dates from 1943. Amended in 1967 and 2011 (technical corrections).	0

<b>475.110</b>	Refusal by able-bodied male to assist in extinguishing fire in timber or brush	Added in 1927. Later changes deal with workers' comp /Silver State Industrial Insurance issues.	0
<b>520.110</b>	Failure to comply with NRS 520.110, "right of stockholders to inspect a company's mines"	Added 1879. Seems like it imposes a potential liability on mine operators.	1
<b>609.245</b>	Employment of a child under 14 years old without written permission of district judge or designee	Added prior to 1911. Non non-technical amendments. Eliminate district judge permission?	0
